WHERE TO OBTAIN COURT RECORDS AND RUN BACKGROUND CHECKS

Court records are housed with the "Clerk of the Court" for most courts. States vary as to the service or entity to order records online. Always call the Clerk of the Court for specific instructions. States and the FBI can also run criminal background checks. Most immigration agencies want fingerprint based background checks.
